



## Next Steps:

#### Organizational workshop in Warsaw

By the **6-9 October**, it will be held the next coordination meeting in Warsaw ( Poland ) and it will be hosted by the partner KZRSIiSN.

Beside the general administration and management issues, the main purpose of this meeting will be the organisation and performing of an INTERNAL WORKSHOP during which ART THERAPY ITALIANA and RE.LEG.ART will guide respectively the session of DANCE MOVEMENT, ART AND HANDICRAFT THERAPY.

The partners and their experts will test the INTEGRATED METHODOLOGY (art/dance movement methodology and craft techniques), before the start up of art/dance movement and handicraft laboratories in Poland, Lithuania, Italy and Bulgaria. The partner UEA will present the calendar as well as the METHODOLOGICAL REPORT that integrates the guidelines for the realization of the art/dance movement and handicraft laboratories.

### Publications:

#### **National Mapping**

The National Mapping, foreseen within the first phase of the project, has been developed and it will be available in the AMM website. It has been developed in two languages: English and partners language too. Its goal/objective has been to produce a participative mapping, which will document the state of the art of all the structures working with "disadvantaged" people and marginalization in different partners countries: Lithuania, Poland, Bulgaria, Italy.

#### **European Mapping**

The EU mapping of social integration systems comes from the National mappings elaborated within the Art Made Man project. Its objective is to have an insight practical view of public and private structures working with "disadvantaged" people and marginalization in the different co-beneficiaries regions/countries.

#### Art therapy guidelines

The Art therapy guidelines have been realized by **ART THERAPY ITALIANA** with the purpose to give the main guidelines to the professionals in the field, how using Art and Dance Movement therapy, patients can paint, model, dance or move around, using the modality that is more functional for their expression and the processing of their experiences, thereby developing interpersonal skills and communication.

#### **Handicraft Guidelines**

The Handicraft guidelines have been realized by **TAMAT** and **RELEGART**, with the purpose to provide social workers dealing with disadvantaged people, new tools and guidance cues with rehabilitation purpose on handicraft therapy, concerning the acquisition of specific skills aimed at achieving a level of autonomy compatible with the expectations of the person or those of the environment.
